- 6. **Financial Report**: Trustee Reynolds reads the report as such: As of February 29, 2020; YTD Total Revenues: \$576,665.27; YTD Total Expenditures: \$205,089.24; YTD Total Net Revenue vs Expenditures \$371,576.03; Total Cutwater Investment: \$777,039.08; Total Cash \$935,203.61.

## 7. Reports:

A. <u>Director and Coordinators</u>: The Schedule for the upcoming events, in partnership with the Detroit Institute of Arts, for the Inside Out program have been confirmed.

Connor, Renee and Director Marble had a phone conference with Hoopla on how the library has done in the year since signing up. The statistics were high and the representatives at Hoopla noted that our numbers for TV and movie checkouts was a lot higher than most other libraries.

Director Marble, along with Trustee Ahern, Trustee Fletcher and Trustee Reynolds, all attended the City's training session on Robert's Rules of Order and the Open Meetings Act. The speakers were very informative, and the library does appear to be abiding by the rules for our meetings.

The Friends of the Library held their annual meeting on February 20<sup>th</sup> at 6:30pm. Trustee Ahern and Trustee Kastran both attended. The Friends approved the library's wish list for Summer Reading and additional events in early fall which include author talks, art show and concerts.

The day after the snowstorm in February it was discovered that the Library was only operating on half of the lights. The City Electrician came over along with members from DPW to determine the cause. It was discovered that a faulty parking lot light was tripping the breaker box and so it was disconnected for the time being. Once that was done the library was up and running on full lighting and able to open on time to the public.

B. <u>Friends of the Library</u>: Alice reports that the Friends are working on their Spring Basket Auction. They are receiving donations.

- C. Additional Umbrella Liability Insurance Coverage: The City Finance Department was not comfortable with the library's liability insurance amount. Kevin Decker was asked to price out what it would cost to add on umbrella coverage which is what the city has.
